On 4/20/2020 the Review Team met to discuss the 2019 aggregate data. The team consisted of Lt. Eldridge, Lt. Warden & Lt. Marriott. The team found that the data currently does not indicate a need for operational changes or physical plant alterations as a measure to reduce or prevent sexual assaults or harassment issues. The team felt that current policies and practices provided sufficient protections; however, a continued emphasis on proper classification and housing reviews are strongly suggested. The team also felt that the staff would benefit from a PREA training review, once the certification process was completed, to solidify a baseline level of knowledge and introduce staff to any new information gained as a result of the audit.
