Review Team Annual Summary:

A sexual abuse incident review takes place at the conclusion of every "Substantiated" sexual abuse investigation. The Review Team's improvement recommendations and implementation status, for this calendar year, are summarized below:

On 02/01/2021 the Annual Review Team consisting of Lt. Warden, Lt Norton and Lt. Marriott convened for the annual summary. The team reviewed the results from the facilities recent PREA Audit which resulted in the facility meeting all 45 applicable PREA standards. Since all corrective actions identified by the audit were implemented in 2020, the team felt no additional actions were warranted at this time. A review of the updated training materials was also conducted to ensure the PREA standards were being met. The team acknowledged that one (1) out of facility complaint was received during 2020 concerning a "Founded" staff on inmate Sexual Assault accusation. As this complaint involved a single incident in 2014 which had been previously investigated and corrective actions implemented, the team verified those safeguards were still in place and that no further actions were needed at this time.
