Review Team Annual Summary:

A sexual abuse incident review takes place at the conclusion of every "Substantiated" sexual abuse investigation. The Review Team's improvement recommendations and implementation status, for this calendar year, are summarized below:

The 2021 Annual Review Team consisted of Lt. Warden, Lt. Conroy, and Lt. Norton. Even though there were no SUBSTANTIATED sexual abuse investigations during 2021, the Review Team identified the laundry distribution areas (one on each housing area) as having the potential to be of concern, from a PREA standpoint, as these locations have poor camera coverage. The topic was brought forward and designated fixed cameras, one per unit, were added to the 2022 fiscal budget. The team also discussed the implications of the recent opening of the "Female Housing Unit" on site. As a result, a review of the current PREA policy / practices was added to the 2022 annual training cycle and made mandatory for all correctional staff.



(Based on a comparison of corrective actions and implementation progress):

The Review Team acknowledged an increase in the "Inmate on Inmate" Substantiated Sexual Harassment complaints (0 in 2020, 3 in 2021). As these were the only substantiated PREA complaints for the calendar year 2020 no specific corrective actions were identified. The facility had recently adopted the use of the "Ohio Risk Assessment" as it's primary classification tool for safe housing. The Review Team felt, that moving forward, the use of this widely recognized industry standard would help reduce the number of PREA complaints and help meet the department's primary goal of Safe Housing for the inmate population.
