Review Team Annual Summary:

A sexual abuse incident review takes place at the conclusion of every "Substantiated" sexual abuse investigation. The Review Team's improvement recommendations and implementation status, for this calendar year, are summarized below:

The calendar year 2022 review team consisted of Lt. Conroy, Lt. Warden & Lt. Banks. The team had previously identified the need for additional cameras in crucial areas of the facility. These cameras were budgeted for in FY 2022 and had just recently been shipped to the facility. The team pushed Rush work orders and had the new cameras installed expeditiously. No further staff incidents have been received since then. The team further emphasized the facility's practice of suspending staff while being investigated and terminating employees who received a "Substantiated" finding by disseminating this information at daily briefings and posting it on public bulletin boards.

Based on a comparison of corrective actions and implementation progress:

The 2 year comparison showed one area of concern, the fact that two (2) Staff Substantiated investigations had occurred. The PREA Coordinator was directed to review the facility's training program and policy. The review found both items to be in compliance with PREA standards. Since both incidents occurred in the previously identified poorly monitored areas, an inspection to verify the installation and good working order of the new cameras was performed with satisfactory results. In an effort to emphasize the department's dedication to its "NO TOLERANCE" policy, every member of the Supervisory staff was assigned training on how to perform PREA investigations. Currently the facility has eleven (11) trained investigators.
